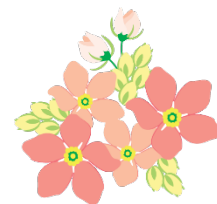


2026 Fall Product Program PARENT/GUARDIAN PERMISSION FORM

- Your Girl Scout must turn the money in on time. All online orders are paid via customer's credit card. In person nut/candy orders are paid for at time of delivery. All money is due December 9th to your daughter's troop leader.
