SU	Review and Submit Troop Initial Orders	YES – same functionality	NO
SU	Review and Submit Troop Recognition Orders	YES – same functionality	NO -
SU	Reports	YES – same functionality	Troop Activity Report all girl and troop digital sales Girl Report - summary information on emails, packages sold and # of orders pending
Troop	Manage Girl User accounts	NO	Can see which girls have set up sites – cannot manage the account or mimic
Troop	Edit girl sizes or recognition program (if applicable)	YES – same functionality	NO
Troop	View Troop Roster	YES	YES
Troop	Create Initial Order	YES – some modifications to initial order process for order taking troops	Do not create the initial order in DC but if an order taking sale, information to populate the initial order will flow to SC
Troop	Create Planned Orders	YES – same functionality	NO
Troop	Create all types of Transfer	YES – same functionality	NO
Troop	Post Girl Payments	YES – same functionality	NO – but will be visible on girl account
Troop	View Payments for troop	YES – same functionality	YES –CC payments will display as well as "offline payments" such as ACH
Troop	Refund Order	NO	YES – no partial refunds – only with council permission in DC24
Troop	Create Recognition Order	YES – same functionality	NO – but can pull report of selections if needed based on council set up
Troop	View Available Inventory	YES – same functionality	NO
